

ORDINANCE NO. 1384

AN ORDINANCE AMENDING THE
VEHICLE PARKING REGULATIONS

The Board of Supervisors of the County of Imperial, State of California, hereby ordain as follows:

Section 1:

Section 10.24.030 and Section 10.24.035 of Chapter 10.24 of Title 10 is hereby rescinded and re-enacted to read as follows:

Section 10.24.030. Vehicle Parking-Restricted.

It shall be unlawful for any person, firm, or corporation to park, or cause to be parked, or left standing, any unattended vehicle of a gross weight exceeding six thousand (6,000) pounds, at any time on the following described routes:

A. North and south sides of "F" Street (WH6) from Third Avenue (WH1) to Railroad Avenue (WH3);

B. East and west sides of Second Avenue (WH2) from "F" Street (WH6) to "D" Street (WH7);

C. East and west sides of Third Avenue (WH1) from Winterhaven Drive (A2P08) south to "D" Street (WH7);

D. North and south sides of "D" Street (WH7) from First Avenue (BU) to Third Avenue (WH1);

E. West side of Imperial Highway (2A04) between Opal Road (2A11) and Mesquite Road (2A19);

F. North and south side of Zinetta Road (GW01) from Clara Nofal Road (GW03) to Rood Road (ER);

G. East and west side of Clara Nofal Road (GW03) from Stergios Road (GW02) to Zinetta Road (GW01);

1 H. East and west side of Rood Road (ER) from 493 feet south of Carr Road
2 (4) northerly to 475 feet north of Maggio Road (GW05);

3 I. North and south side of Carr Road (4) from Ninalee Road (GW04) to
4 Rood Road (ER);

5 J. East and west side of Menvielle Road (GW06) from SR 98 to SR 7;

6 K. North and south side of Stergios Road (GW02) from Clara Nofal Road
7 (GW03) to Rood Road (ER);

8 L. East and west side of Ninalee Road (GW04) from State Route 7 southerly
9 to 493 feet south of Carr Road (4);

10 M. East and west side of Menvielle Road (GW06) from State Route 7 to
11 Menvielle Court (GW07);

12 N. North and south side of Menvielle Court (GW07);

13 O. North and south side of Maggio Road (GW05) from State Route 7 to
14 Rood Road (ER);

15 Section 10.24.035. Parking Restricted on SR-7 and SR-98.

16 It shall be unlawful for any person, firm, business, or corporation to park, cause to
17 be parked, or leave any unattended vehicle on the following described locations:

18 A. Any portion, either direction along SR-7;

19 B. Along SR-98, either direction, from 500 feet West of Menvielle Road (GW06) to
20 500 feet East of SR-7.

21 Section 2:

22 This Ordinance shall take effect and shall be in force sixty (60) days after the date of its
23 adoption and prior to the expiration of fifteen (15) days from the passage thereof, shall be
24 published at least once in the Holtville Tribune, a newspaper of general circulation, printed and
25 published in the County of Imperial, State of California together with the names of the members
26 of the Board of Supervisors voting for and against the same.


